

**PRIVACY POLICY OF
FAZELI VINEYARDS, LLC, A CALIFORNIA LIMITED LIABILITY FAZELI CELLARS, WHICH DOES
BUSINESS AS FAZELI CELLARS**

1. Fazeli Vineyards, LLC, a California Limited Liability Fazeli Cellars, which does business as Fazeli Cellars (referred to as Fazeli Cellars”), Commitment to Privacy. This notice describes Fazeli Cellars’ privacy policy. Fazeli Cellars’ privacy policy is designed to advise the site user (“User”) and attendees on the Fazeli Cellars premises, about how Fazeli Cellars collects, uses, and protects the personal information provided. By visiting this site, User is accepting the practices described in this privacy policy.

2. What Information is collected.

(a) Information Provided to Fazeli Cellars: Fazeli Cellars collects any information entered on its site, or that is given to Fazeli Cellars in any other way. A User can choose not to provide certain information, but the User may not be able to take advantage of Fazeli Cellars’ services and features.

(b) Automatic Information: When a User visits the website, the User discloses certain information, such as the User’s Internet Protocol (IP) address and the time of the User’s visit, which is automatically provided to Fazeli Cellars. This site, like many other sites, records this basic information about visits to the site.

(c) "Cookies": Cookies are pieces of information that are transferred to a computer from a web server. Most browsers are set up to accept cookies, but a User may change User’s settings to have User’s browser notify User when a new cookie is requested or to refuse to accept cookies.

3. How and When the Information is used. The information Fazeli Cellars collects is used for administering its business activities. Occasionally, Fazeli Cellars may use the information to notify Users about changes to the website, new services, or special offers.

4. How FAZELI CELLARS Protects Information. The privacy and protection of information is important to Fazeli Cellars. Fazeli Cellars does not make any personal information available to third parties without permission.

Access to some services and content may be password protected. If so, Fazeli Cellars advises that the User should not disclose the password to anyone. In addition, Fazeli Cellars recommends the User to sign out of password-protected services at the end of the session.

5. Methods We Use to Protect Information. Fazeli Cellars uses security software to protect the confidentiality of personal information. In addition, Fazeli Cellars’ business practices are reviewed periodically for compliance with policies and procedures governing the security and confidentiality of the information. Fazeli Cellars’ business practices limit employee access to confidential information, and limit the use and disclosure of such information to authorized persons.

6. Age Limitation. This website does not provide services or sell products to anyone under the age of 21.

7. Consent. By using the website, User consents to the collection and use of personal information as described in this Privacy Policy and affirms that the User is at least 21 years of age.

8. Changes to Privacy Policy. If this Privacy Policy or procedures change, Fazeli Cellars will immediately post the changes on the website. Any such changes will be effective immediately upon being posted, unless otherwise stated in the change.

9. Image and photo policy. Anyone that enters the Fazeli Cellar’s premises understands that there will be ongoing filming and/or pictures taken both for social media, advertising, and security. By entering these premises, you specifically give consent to photographic, or video being taken while you are on the facility, and further consent to the use of these items and social media, advertising, and when necessary for security purposes. If you do not want to consent to the above, please elect not enter the premises.

10. Effective Date. This current Privacy Policy is effective as of January 23, 2025.
